Producer's description

The System Sensor, Model 2012/24AUSI, 12/24Vdc externally powered with 9 Vdc battery back-up, silencing/test facility, relay output, interconnectable, photoelectric smoke alarm is an externally energized photoelectric smoke alarm. The smoke alarm's primary power supply is an external 10 Vdc to 30 Vdc supply. The smoke alarm includes a standby power supply from a non-rechargeable battery which is user replaceable.

An electric buzzer/horn provides an audible alarm signal when the smoke alarm senses smoke which exceeds a predetermined level. When the smoke level drops below the alarm level, the buzzer/horn is de-energized. A self-test facility is provided. If the button is depressed an alarm signal is emitted.

The System Sensor, Model 2012/24AUSI, 12/24Vdc externally powered with 9 Vdc battery back-up, silencing/test facility, relay output, interconnectable, photoelectric smoke alarm incorporates a silence feature. Pressing the Test/Silence button will enter the smoke alarm into a silence mode for approximately 8 minutes.

The smoke alarm is circular in shape. It is approximately 135 mm in diameter and has a height of approximately 55 mm. It clips into a circular mounting base with holes for screws. The internal mesh is rectangular in size.

Technical specification
